How can Search Engines be better front doors to the legal system?

Given how many people try to solve their problems by going to Google, Bing, Yandex, or Yahoo

How do we serve correct legal info, options, and actions to people who need help?

Given that courts' and governments' websites are most often poorly designed and difficult to navigate, despite people's clear preferences for this official information over for-profit sources, or generic descriptions

How do we get legal support to people on their terms, in engaging ways?

Using a user-centered design methodology, how do we understand the legal system from lay-people's point of view, so we can make it work for them, on their terms.

	If you've voted in California before, you don't need to show ID										
	If you're a first-time voter, registered by mail, and didn't include your driver's license number, California ID number, or the last 4 digits of your Social Security number on your registration, you need to include a copy of accepted ID with your mail-in ballot and you may be asked to provide ID if you vote in person										
	Acceptable forms of ID include a current and valid photo ID that includes your name and photograph. Examples:





What's a **user-friendly schema** of some key legal help issues?


